Governor Healey Signs First Tax Cuts in More Than 20 Years.

"Senior Circuit Breaker Tax Credit – doubles credit, indexed to inflation, which equates to an increase from \$1,200.00 to \$2,400.00".

The Town of Wayland currently matches State Income Tax Circuit Breaker Credit (\$1,200.00). In discussions with Julie Secord [Council on Aging (COA) Director], Brian Keveny (Director of Finance), and Assessor's Office staff, at this time, we believe modifications to the Town of Wayland's existing program are not necessary.

CY 2024 FY 2025 Senior Tax Work Off (STWO) Program

Bureau of Municipal Finance Law Informational Guideline Release (IGR) No. 23-10 November 2023; Section GUIDELINES: LOCAL ACCEPTANCE; Maximum Abatement and Hourly Rate.

"The maximum abatement volunteers may earn for a fiscal year is \$2,000.00 for seniors and \$1,500 for veterans"; Effective CY 2024 / FY 2025.

At the 2021 Annual Town Meeting, the Town of Wayland passed by majority, "allowing the maximum reduction of the real property tax bill to be based on 125 volunteer service hours in a given tax year, rather than \$1,500"; (at that time, the maximum abatement amount).

The FY 2024 maximum abatement amount is \$1,875.00 [125 hours x \$15.00/hr (minimum wage)].

In discussions with Julie Secord (COA Director), Brian Keveny (Director of Finance), and Assessor's Office staff, at this time, we believe modifications to the Town of Wayland's existing program are not necessary.

Request for Motion by Philip Parks to acknowledge changes to the DLS Senior Citizen and Veteran Tax Work-Off program per IGR No. 23-10 and agree to take no action at this time to modify the Town of Wayland Senior Tax Work Off Program. (The Town of Wayland will continue to allow maximum of 125 hours at minimum wage in lieu of new guidelines).
