#### Minutes

The minutes of the September 7, 2023 Community Preservation Committee (CPC) meeting were reviewed and comments provided. K. Gardner-Westcott made a motion to accept the minutes, as amended. I. Montague seconded the motion. The September 7, 2023 minutes, as amended, were approved unanimously 6-0-0 (Weinstein-yes; Cavanaugh-yes; Gardner-Westcott-yes; Montague-yes; Pierce-yes; Stotz-yes).

## **Community Preservation Coalition Dues**

Payment is due on Wayland's annual membership fee in the Community Preservation Coalition (Coalition) at the rate of \$4,350. D. Stotz made a motion to allocate \$4,350 from the Administrative Fund for Coalition dues. K. Pierce seconded the motion. The allocation of \$4,350 for Coalition dues from the Administrative Fund was approved unanimously 6-0-0 (Weinstein-yes; Cavanaugh-yes; Gardner-Westcott-yes; Montague-yes; Pierce-yes; Stotz-yes).

## **Grout Heard House**

G. Schuler explained that the Wayland Historical Society and Museum received one bid at \$20,000 for a structural analysis of the Grout Heard House. The CPC previously voted to approve allocating \$17,500 from the Administrative Fund for a structural analysis; G. Schuler is requesting an additional \$2,500. In addition, to complete the analysis, removal of the insulation is required to expose the structure at a cost of \$1,200. G. Schuler explained that an additional \$5,000 may be needed to complete a site plan, though the Town may be able to prepare the plan. Following discussion, CPC members agreed on approving \$3,700 for the structural analysis and insulation removal. If an additional \$5,000 is needed, G. Schuler will request at a future CPC meeting. I. Montague made a motion to approve an additional \$2,500 for the structural analysis and \$1,200 for removal of insulation from the Administrative Fund. D. Stotz seconded the motion. The allocation of \$3,700 for the structural analysis and insulation removal of insulation from the Administrative Fund was approved 5-0-1 (Weinstein-yes; Cavanaugh-yes; Gardner-Westcott-abstain; Montague-yes; Pierce-yes).

## **New Project Applications**

S. Weinstein confirmed that Community Preservation Act applications for 2024 Annual Town Meeting have been circulated to boards, departments, local newspapers. Applications are due by November 30, 2023.
